What do we do at camp?

Young participants will have a fun hands on learning experience with horses. Each week will have a different equine educational theme. During camp, participants will be taught horsemanship skills, responsibility, patience and leadership. Some of the activities included are...

Under Illinois law, an equine activity sponsor or professional shall not be liable for any injury to, or the death of a participant in equine activities resulting from the inherent risk of equine activities. I acknowledge the risks and potential for risks of horseback riding and related equine activities involving equines and/or farm animals, the potential dangers that could incur including, but not limited to, any injuries or incidents caused by negligence, relating to injuries known, unknown, or otherwise not herein disclosed; death or property damage from: mounting; riding; dismounting; walking; grooming; use of horse barn, paddock, trails or horse ring, arena, round pen, in any capacity; falling off horse whether horse is bucking, flipping, spooked; or my failure to understand directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse being ridden, boarding, feeding said horse; including, but not limited to, any interactions with other horses.
